Purchaser may cancel a resale disclosure within 2 days or up to 7 days (of contract or delivery) if extended by contract whether or not resale certificate is complete. Resale Certificate is deemed "Not to be available" if a current annual report has not been filed by the Association and the Common Interest Community Board or with the State Corporation Commission.
